4a Community Impact Fund - United Way of Pierce County completed the second year of a three-year funding cycle that engaged 45

volunteers from the public, private, nonprofit and philanthropic sectors who reviewed grant applications. The goal of the 2017-2019

investment process is to be intentional on how we are collectively breaking the cycle of poverty through our County's various strategies.

We must have accountability toward impact and better utilize resources toward a foundational shift on continuous improvement. 34 agencies

were funded who demonstrated the strongest alignment to the criteria outlined in the RFP and articulated how their work impacted barriers

that addressed poverty.

Funding recommendations were reviewed and approved by United Way of Pierce County board of trustees.

United Way of Pierce County is committed to our goal to break the cycle of poverty by lifting 15,000 households out of poverty by 2028, one

family at a time. We cannot do this alone, so as a key community convener, we are breaking down the siloes of interconnected work that

addresses poverty within government, nonprofits, funders, faith-based organizations, neighborhoods and the private sector.

In 2018, 124,105 Pierce County residents received services from food and shelter to child development support to education and employment

services. Out of this number, 76% of clients who agreed to be assessed (11,416) demonstrated progress going from crisis to

self-sufficiency.

4c Gifts in Kind Program - This program receives new and gently used in-kind donations from individual donors and businesses, such as technology equipment, office and home furniture, toys, clothing, bedding, household appliances and event tickets. Donations are distributed to nonprofit agencies free of charge. We have established ongoing relationships with local businesses that make consistent donations of quality goods on a scheduled basis. The total value of goods distributed to community nonprofits in the Puget Sound area of Washington was \$688,872. The cost to run the program was \$58,322; combined together the total was \$747,194.

4d Other Program Services:

Community Impact- United Way of Pierce County continues to measurably improve the lives of people in our community by funding critical programs, operating South Sound 2-1-1, a core component of the community safety net and working with community partners to tackle the toughest health and human service issues that are blocking people from self-sufficiency in Pierce County. In 2017, we made a bold commitment to lift 15,000 households out of poverty by 2028. This takes a community-wide effort of strong collaborations, agreeing on key measurements and tracking indicators with nonprofits, government, educators and businesses.

In July of 2016, we launched our Center for Strong Families, a proven model that has been deployed in low-income neighborhoods to increase financial stability for individuals and families that are struggling. The model has proven successful in nearly 100 other communities in the country. Starting with two centers in 2016, we now boast a network of seven sites. 843 families have enrolled in services since inception with 324 enrolled in occupational training, 316 placed in jobs, 151 decreased debt by an average of \$12,000 per year, 157 improved their credit, 157 increased assets by \$13,500 and 137 increased wages.

Together the Centers helped 581 clients in 2018 compared to 507 in the prior year.

In 2015, we created our Hunger-Free Pierce County Collaborative to ensure that families across Pierce County have access to nutritious food. Our fifth refrigerated food truck was purchased in 2018, which is shared by food banks to mobilize health food around the County. Vans were used for food rescue, meal delivery, gleaning and perishable donation pickups resulting in nearly 250,000 pounds of food or the equivalent of more than 220,000 meals.

A past investment in a high tunnel growing space at the Mother Earth Farm produced over 10,000 pounds of healthy produce.

Our volunteer engagement, crockpot project provided 1,246 crockpots along with 7,200 soup kits providing more than 28,800 meals.

Colorfull Cooking Made Easy Classes were introduced in 2017 and continued in 2018. Last year, 15 trained volunteers provided on-site cooking demonstrations at five local food banks. As a result, food pantries reported less food waste, and improved nutrition for clients.

\$38,000 was invested in the Power Pack provider network serving more than 2,500 students countywide providing over 535,609 meals and snacks to kids and their families.

Program costs for this core program area \$733,103.

South Sound 211- This free and confidential service connects people with critical resources that help to stabilize individuals in Pierce, Thurston and Lewis counties. South Sound 2-1-1 connected 89,214 individuals with assistance compared to 79,000 in 2017. On-the-ground navigation services in the area of transportation, behavioral health, basic food and housing were able to provide individuals and families 583 rides, 334 food benefits and 47 stable housing solutions. Other examples of individuals connected via 2-1-1 call specialist to services: 5,599 rental assistance; 2,661 emergency shelter; 2,743 transportation services and 404 families connected to affordable quality childcare. The top ten requested needs were: rent/deposits, utilities, low cost housing, transportation, emergency shelter, legal, food, behavioral health and holiday assistance. Advocacy: United Way of Pierce County provides guidance on state policies and positions. It focuses on issues most important to Pierce County by supporting legislative and policy activities that address our work in breaking the cycle of poverty. We focus on building strong families through economic stability, helping kids be successful and ensuring there are emergency services for people in need. Thanks to a sustained effort, we helped to ensure funding for key regional and statewide programs that help low-income families.

LIL Readers - In partnership with the Pierce County Library System, the Volunteer Engagement team is coordinating the Launch into Literacy (LIL) Readers Program. Volunteer readers, who are trained by Pierce County Library System's early learning staff, share books and activities provided by PCLS at small and in-home child care centers. In 2018, 15 volunteers were placed at various child care sites and engaged in 300 hours of service in reading and learning activities.

READ United: Summer Learning - Staff and volunteers visited meal sites in high-need neighborhoods across the county to provide free books for the children. Over the course of the summer, we engaged 55 volunteers in weekly reading and activity sessions with children.
