We saw this come to life through our Basic Income initiative, GRIT, (Growing Resilience in Tacoma), where participants helped reimagine how we support families. Within our Center for Strong Families network, over a third of participants took bold steps toward education or employment. And in our two-generation partnerships, families didn't just survive–they gained the tools to thrive.

Through a partnership with United Ways of the Pacific Northwest and funds as part of the state's Community Reinvestment Plan, we're able to offer matched savings through Individual Development Accounts (IDAs), helping individuals build assets to start or grow a business, buy a home, pursue education, or secure reliable transportation.

Because poverty isn't just about income–it's about access, opportunity, and choice. And too often, ALICE® (Asset-Limited, Income-Constrained, Employed) families have none of the above.

But we're changing that.

With your support, we're investing in programs that restore choice, build resilience, and move families toward lasting stability–from housing and food to workforce development, child care, and mental health.

Together, we're turning possibility into progress. United is the Way forward–and we're just getting started.



With inspiring speakers, expert-led workshops, and strong community support, this inaugural event laid the foundation for an annual tradition of empowering women to thrive.

- What if every system was built for equity?
- What if solutions started with listening?

Keynote speaker H. Luke Shaefer urged us to shift away from blame and toward bold policies—like child tax credits and safety nets that actually work.



In 2024, we officially launched the **Black/African American Leadership Circle**, focused on providing support to Black ALICE households.



Financial Coaching

You helped place financial coaches at Workforce Central's One-Stop & Tacoma Community College

These coaches provide real-time, personalized support–budgeting, saving, planning–so individuals can build long-term financial independence and stability. In June 2024, the 24th Annual Willie Stewart Community Service Scholarship honored 15 Pierce County Seniors with scholarships. United Way and local leader Willie Stewart granted \$2,500 to each scholarship recipient. Recipients will use their awards to help pay tuition at colleges and universities across the country.



Center for Strong Families integrates employment coaching, financial coaching, and access to income supports, in order to address the unique challenges faced by ALICE families, equipping them with the tools and resources necessary to build stronger financial futures.



Financial Education & Digital Literacy Workshops

In today's fast-paced, technology-driven world, financial education and digital literacy are more important than ever. Together, they empower individuals to make informed financial decisions, safely navigate online platforms, and access critical tools and services that support economic mobility and long-term stability.

Building Financial Strength

- **26%** increased net income
- 17% increased net worth
- **15%** improved their credit score
- 48% achieved financial goals

Out of the 779 participants engaged in financial coaching, hundreds saw measurable financial progress – from income growth to goal achievement. Since 2016, Center for Strong Families has engaged over 5,000 clients! Our vision is that every person has the opportunity to learn, work, and thrive in all aspects of life.

RAISING OUR COLLECTIVE Voice for families in Pierce county

\$1M IN NEW STATE FUNDING FOR 211

\$1.2M In added support for early Literacy through the Imagination Library In 2024, we spoke up for policies that make life better for ALICE households–focusing on housing, hunger, early learning, and basic needs.

Together, We Achieved:

- More support for families receiving child support
- Tax breaks to help nonprofits build affordable housing
- New investments to help working families own homes

How We Showed Up Together:

We met with 19 legislators and brought 13 local volunteers to share what's really happening in our community—from the high cost of housing to the need for affordable childcare and stronger safety nets. Because when we advocate together, we make real change happen.

GRIT GROWING RESILIENCE IN TACOMA (GRIT): GUARANTEED BASIC INCOME

GRIT 2.0: Cash Assistance Project

Our newest initiative, Growing Resilience In Tacoma (GRIT) 2.0, is a collaborative guaranteed basic income program run by UWPC, in partnership with DSHS, the City of Tacoma and Pierce County. In April 2024, GRIT provided a **\$500** monthly stipend for 12 months to **175 ALICE families**. Participants are working single head-of-households with children under 18. From our previous GRIT project, we know that families used the dollars to reduce debt, pay for basic needs, increase credit, spend more time with their loved ones, and better their mental health.



"The GRIT payment is lifting a weight off of my shoulders! My mother just passed, and I have to fly to California, where my family is from. I am the eldest of 14 so it all falls on me. I have used the last 3 months of funds wisely, so I have money to go take care of things for her funeral. You told me about Sun Bucks, so that is also helping. I am looking forward to Christmas-in-July to help with more ways to save. Thank you so much for being here."
